Act | East supports national neglected tropical disease (NTD) programs to reach WHO NTD control and elimination goals through proven, cost-effective public health interventions. The Act to End NTDs | East Program also provides critical support countries in their journey to self-reliance, helping them to create sustainable programming for NTD control within robust and resilient health systems.

Roles and Responsibilities

The Gender Specialist will work with the headquarters and country programs for the Act to End NTDs | East program to integrate gender equity and social inclusion into program activities, trainings, tools, and resources; to conduct gender equity and social inclusion analyses; and to develop local capacity of policy makers and program managers on gender integration and social inclusion to improve NTD program outcomes. The Gender Specialist will serve as the key point of communication between RTI, and WI-HER. Specific activities are listed below.

- Provide senior level technical support to country programs in gender integration and social inclusion in NTD programs
- Conduct fieldwork and qualitative research such as focus group discussions, community assessments, co-creation activities, and behavior change activities, etc.
- Conduct data analysis and report writing
- Knowledge management and documentation
- Conduct capacity building and training in gender integration and social inclusion in NTD
- Provide ongoing mentoring and coaching to country programs in gender integration and social inclusion
- Build collaborative networks at all levels

- Develop gender integration and social inclusion tools and resources
- Leverage funding from the private sector in support of program activities
- Contribute to monthly, quarterly and other USAID required reports
- Produce KM Materials, such as blogs, reports, and publications
- Attend regular meetings with project staff and support project activities

The Gender Specialist reports to the Regional Director at WI-HER.
